

SONG DEMO PRODUCTION AGREEMENT

(herein known as **the company**), 1918 Rutherford Drive, Dover, FL 33527, for the tendering of personal services

IN CONSIDERATION of the mutual covenants herein contained, the parties hereto agree as follows:

**Barclasion Music** will provide the following services that have been indicated;

\_\_\_\_\_ "Add Ons". such as strings, synth parts, percussion, saxophone, BGVs, etc.

\_\_\_\_\_ Postage is billed at \$5 for 1 item being sent regular US mail. Larger quantities of masters  
and/or dubs will be billed according to weight. Other fees will apply if FedEx or UPS  
services are requested for domestic or international shipping.

The company will provide one set of revisions to the arrangement prior to recording of demo vocals and any "real  
guitar parts or horn parts". Two or more revisions will be billed at \$50/hr. Vocalist and guitar revisions are  
subject to another full fee.

The company will have no claim to copyright royalties unless the company assists in melodic and/or  
lyrical additions or changes. Then publishing issues will be addressed and agreed upon before  
completion of the aforementioned composition.

**The Client** is responsible for providing and agrees to the following items;

1. A \$75 (seventy five dollar) non-refundable good-faith retainer fee which is deducted from the final bill at the completion of the project. (for multiple songs, only one retainer fee is required.)
2. A CD or cassette with an audible demonstration of the melody with a lyric sheet and any chord progressions that you may have already.
3. The client hereby warrants that the composition is an original work and Barclasion Music will be held harmless in the event any copyright infringements have been violated by the client.
4. The client agrees that the final track is to be used for demo purposes only; such as pitching to record labels, publishers or other artists. In the event the track is used as part of a product that is being offered for sale to the public, use in TV or film, then additional fees will apply and the client agrees to make contact with the company informing of such events. Proper credit will be required on all such products made available for sale.

The total amount of \$\_\_\_\_\_ is due for services rendered. Payment is due upon receipt of the final product minus the \$75 retainer fee paid up front.
